(Date Range for Record Search: From 06/26/2019 To 08/30/2019). I seek only clearly releasable information. I am affiliated with a private business, "company name) and I am seeking information for use in the company's business. I am willing to pay fees for this request up to a maximum of \$100.00.

- (1) Explanation: For "clearly releasable" records, you accept as a "full release" responsive documents with/without redactions and no explanation for redactions. We are not legally required to explain the FOIA exemptions used to justify the redactions in a "clearly releasable" request. This allows us to provide information to you faster. You can always appeal or start a new request for the same information with an explanation—if there are redactions to the "clearly releasable" documents. There is no problem if you are not willing to accept "clearly releasable" information!
- (2) Explanation: Requester Category. I am a...
- ...affiliated with a private business (commercial) and am seeking information for use in the company's business.
- ...affiliated with an educational or noncommercial scientific institution (education/scientific), and this request is made for a scholarly or scientific purpose and not for a commercial use.
- ...a representative of the news media (other) affiliated with the _____ newspaper (magazine, television station, etc.), and this request is made as part of news gathering and not for a commercial use.
- ...an individual (other) seeking information for personal use and not for a commercial use.
- (3) Explanation: Indicate a willingness to pay minimum fees of \$25.00 for processing the request and/or maximum you are willing to pay for the information, or if seeking a waiver provide an explanation. Fess are based on the requester's category and the OPR's government grade (pay rank/grade) who is tasked to search/review documents. [I am willing to pay a minimum fee of \$25.00 for processing this request.] [I am willing to pay fees for this request up to a maximum of \$100.00...]. Fees under \$25.00 are not charged. In the event the fee exceeds the willing amount, you will be contacted by the RSC before continue to process the request.

Category 1: Commercial. Requesters pay all search, review, and duplication.

Category 2: Educational or Noncommercial Scientific Institution or News Media. Requesters get the first 100 copies free and pay for additional copies.

Category 3: Others. Requesters get the first two hours of search and the first 100 copies free.

(4) Explanation: Expedited Request

A requester may ask for expedited processing by providing a details statement demonstrating that the request involves:

- 3) Loss of substantial due process rights.
- 4) A matter of widespread and exceptional media interest in which there exists possible questions about the government's integrity which affect public confidence.
