Real Estate Management is the process of managing space and transactions at an installation and consists of four sub-processes: Manage Transactions, Manage Space Occupancy, Manage Contracts, Conduct Move Planning and Management. It also involves providing data conversion reports on a weekly basis based on this 6 month schedule for each installation. These tasks occur for 1-2 installations "going live" on a weekly basis. The schedule is also broken into 5 distinct sets of installations called "Waves." This deployment started in June 2016 and is expected to take up to 3 years to complete. Sustainment services will include baseline change requests for enhancing current capabilities, compliance activities (CFO, RPIM, Blue Book, FISCAM), determining gap analysis for future capabilities, database management and Help Desk level II and III support. Certified IBM TRIRIGA expertise is required.
