

## Small Business Updates



#### • 13 CFR 125

- 13 CFR 125.3 and 13 CFR 125.11 updated
- Implemented provisions from FY2021 NDAA
  - Allows consideration of 1<sup>st</sup> Tier Subcontractor or JV Past Performance with offers on prime contracts.
  - Requires subcontracting plans to include requirement that Large business to provide the PP information if requested by the Small business
- Does not "mandate" Procurement offices to use Past Performance information
  - No change has been made to the FAR or supplements requiring implementation
- Effective 22 August 2022

### Final Rule (DFARS Case 2020-D009)

- Implements Section 872 of FY2020 NDAA
  - Reauthorizes and modifies the DoD Mentor-Protégé program (DFARS 219.71)
    - Rule benefits small business concerns by extending the opportunity to enter into DoD mentor protégé agreements
    - Effective 24 October 2022
